# 2025 TERM DATES & PAYMENT STRUCTURE

## **The pricing and payment structure for 2025 are as follows:**

- Pro rata payments will be calculated for new students starting mid-term or current students leaving mid-term. Remember, we require one month written notice for the cancellation of swim lessons
- New swim students:
  - The swim assessment fee is R65 and payable on the day of the assessment
  - Should you decide to register with Water Orphans for further swim lessons, there will be a once off registration fee of R650 per student, payable upon registration
  - New students will receive a Water Orphans T-shirt and a personal record book once the registration fee has been paid
- Term fees are payable in advance and should be paid in full during the first week of each term, alternatively you may select to pay the term fee in three equal monthly instalments, in advance.
- Should you elect to pay monthly, the monthly fees are payable in advance, in three equal instalments, by the first of every month. Please refer to the schedule below for the payment structure, payment due dates and amounts.
- Students will not be allowed to attend lessons if fees are outstanding on their account.
- Fees may be paid by EFT, Credit Card or Cash. We offer a 10% discount on all cash payments. If the cash payment option is selected, the total term fee must be paid in cash (per term or per month, in advance), to qualify for the 10% discount.
